ACTS

This table lists the statutes in force in the Cook Islands as at 1 March 2016. ‘R&C’ means request and consent, and refers to an Act passed by the New Zealand Parliament in accordance with the former article 36 of the Cook Islands Constitution.

A basic list of statutes of British Imperial origin still in force in the Cook Islands is provided in *Laws of the Cook Islands 1994* vol 1 p106. The statutes listed there have been affected by post-1994 Cook Islands legislation such as those statutes indicated in the Editorial Note to this volume.

In some Acts there is a power to amend the Act by regulation. Where that power has been expressly exercised, the amending legislation is indicated by “Reg”. All other amendments are by Act designated by year and number. “SR” refers to the Statutory Regulations of New Zealand. “NIF” indicates that the Act is not in force.
