#### Regulations

- Title**  
These regulations are the Maritime Rules (Offences) Regulations 2014.

**2 Commencement**

These regulations come into force on 1 January 2015.

**3 Interpretation**

In these Regulations, unless the context otherwise requires—

**Act** means the Maritime Transport Act 2008

**Convention** for the purposes of these regulations means any bilateral or multilateral treaty, convention, code, agreement or understanding relating to maritime transport; safety, security or marine pollution to the extent the Cook Islands is party or has agreed to adopt and enforce

**Person** includes the owner or charterer and master of a vessel and a seafarer employed on a vessel and also includes a corporation

**Rules** means, maritime Rules and marine protections Rules made under the Act.

**4 Application**

These Regulations apply to—

- (a) all vessels registered on the Cook Islands Ships Register; and
- (b) all seafarers who are employed on vessels referred to in paragraph (a) of this Regulation; and
- (c) all owners, charterers and masters of vessels referred to in paragraph (a) of this Regulation.

*Compliance*

**5 Responsibility for compliance**

It is the responsibility of an owner or charterer and master of a vessel to ensure that the vessel and each seafarer employed on the vessel comply at all times with,—

- (a) all Rules applicable to the vessel or a seafarer;
- (b) all conventions applicable to the vessel or a seafarer.

**6 Offences**

- (1) An owner or charterer and master of a vessel who fails to ensure that the vessel and each seafarer employed on the vessel complies with paragraphs (a), and (b) of section 4, as the case may be, commits an offence against the Act.
- (2) A person who contravenes a provision of Schedule 1 commits an offence against the Act.
- (3) If a single act or omission amounts to more than one offence then a separate prosecution may be brought for each offence.
- (4) A person who commits an offence as provided for in these Regulations is liable on conviction—
  - (a) in the case of an individual, to a fine not exceeding \$100,000.00;
  - (b) in the case of a body corporate, to a fine not exceeding \$500,000.00.

**7 Strict Liability**

- (1) In a prosecution for an offence it is not necessary for the prosecution to prove the defendant intended to commit an offence.

- (2) It shall be a defence in any prosecution, if the defendant proves the defendant did not intend to commit the offence and that—
- (a) if it is alleged that anything required to be done was not done, the defendant took all reasonable steps to ensure it was done;
  - (b) if it is alleged that anything prohibited was done, the defendant took all reasonable steps to ensure it was not done.
