AN ACT

TO APPROPRIATE A FURTHER SUM OF THIRTY MILLION, ONE HUNDRED AND SEVENTY THOUSAND AND SEVEN HUNDRED DOLLARS IN ADDITION TO THE SUM PREVIOUSLY APPROPRIATED TO THE SERVICES OF THE GOVERNMENT FOR THE PERIOD ENDING 31ST DECEMBER 2003; AND TO REGULARISE THE REDEPLOYMENT OF FUNDS FROM HEAD 50 OF THE 2003 BUDGET TO VARIOUS HEADS FOR THE SERVICES OF THE GOVERNMENT FOR THE PERIOD ENDING 31ST DECEMBER 2003.

ENACTED by the Parliament of the Fiji Islands—

Short title

1. This Act may be cited as the 2003 Appropriation (Supplementary) Act 2003.

Appropriation of \$30,170,700

2. The sum of \$30,170,700 is appropriated and applied to the services of the Government for the period ending 31st December 2003 as set out in column 4 of the Schedule.

Redeployment of \$3,411,973

3. A sum of \$3,411,973 is redeployed from head 50 and transferred to various Heads for the services of the Government for the period ending 31st December 2003 as set out in column 6 of the schedule.
