(CAP. 73)

**Counter-Inflation (Price Control) (Foodstuffs)  
(No. 7) (Amendment) (No. 1) Order 2010**

IN exercise of the powers conferred upon it by Section 9 of the Counter-Inflation Act, the Prices and Incomes Board with the approval of the Prime Minister and Minister for Finance makes the following Order—

*Citation and commencement*

- 1.—(1) This Order may be cited as the Counter-Inflation (Price Control) (Foodstuffs) (No. 7) (Amendment) (No. 1) Order 2010 and comes into force on 10th April 2010.  
(2) The Counter-Inflation (Price Control) (Foodstuffs) (No. 7) Order 2009 is in this Order referred to as the Principal Order.
