AND WHEREAS I, in exercise of the powers vested in me as Vice-President of the Republic of Fiji by the Office of the Vice-President and Succession Decree 2009 (Decree No. 8) and by the Executive Authority of Fiji Decree 2009 (Decree No. 2), revoked with effect from the 3rd day of August 2009, all assignments of responsibilities conferred on you as aforesaid, and with effect from the same day assigned to you in your capacity as Minister for Education, National Heritage, Culture and Arts, Youth and Sports, Labour, Industrial Relations, Employment, Local Government, Urban Development, Housing and Environment, the responsibility for the conduct of the Government business and departments and the written laws specified in Legal Notice No. 70 of 2009;

AND WHEREAS I, in exercise of the powers vested in me as Vice-President of the Republic of Fiji by the Office of the Vice-President and Succession Decree 2009 (Decree No. 8) and by the Executive Authority of Fiji Decree 2009 (Decree No. 2), revoked with effect from the 20th day of August 2009, all assignments of responsibilities conferred on you as aforesaid, and with effect from the same day assigned to you in your capacity as Minister for Education, National Heritage, Culture and Arts, Youth and Sports, Labour, Industrial Relations and Employment, the responsibility for the conduct of the Government business and departments and the written laws specified in Legal Notice No. 74 of 2009;

AND WHEREAS I, in exercise of the powers vested in me as the President of the Republic of Fiji and Commander in Chief of the Republic of Fiji Military Forces by the Executive Authority of Fiji Decree 2009 (Decree No. 2), revoked with effect from the 22nd day of February 2012, all assignments of responsibilities previously conferred upon you, and with effect from the same day assign to you in your capacity as the Minister for Education, National Heritage, Culture and Arts, the responsibility for the conduct of the Government business and departments and the written laws specified in Legal Notice No. 32 of 2012;

NOW THEREFORE, in exercise of the powers vested in me as President of the Republic of Fiji and Commander in Chief of the Republic of Fiji Military Forces by the Executive Authority of Fiji Decree 2009 (Decree No. 2), I hereby revoke with effect from the 1st day of January 2014, all assignments of responsibilities as recited above, and with effect from the same day assign to you in your capacity as the Minister for Education, National Heritage, Culture and Arts, the responsibility for the conduct of the Government business and departments and for the following written laws (subject to the provisions of any other written laws)-
