

PRESIDENTIAL COMM. NO. 7-174
FSM CONGRESS

AN ACT

To amend Public Law No. 7-35, Chuuk State public projects, by amending sections 3 and 4, for the purpose of allocating the funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 7-35 is hereby amended
2 to read as follows:

3 "Section 3. Southern Namoneas public projects. The sum of
4 \$595,000, or so much thereof as may be necessary, is hereby
5 appropriated from the General Fund of the Federated States
6 of Micronesia for the fiscal year ending September 30,
7 1992, for the purpose of funding public projects in
8 Southern Namoneas, Chuuk State. The sum appropriated by
9 this section shall be apportioned as follows:

- 10 (1) Tonoas economic and social projects..... \$136,000
- 11 (2) Uman economic and social projects..... 130,000
- 12 (3) Fefen economic and social projects..... 132,000
- 13 (4) Tsis economic and social projects
 - 14 (a) Sanga Ruu Ut supplement..... 1,500
 - 15 (b) Usonut Ut supplement..... 1,500
 - 16 (c) Ipat seawall..... 4,000
 - 17 (d) M & S sewing association..... 3,000
 - 18 (e) N & M fishing project..... 5,000
 - 19 (f) Other public projects..... 12,000
- 20 (5) Parem economic and social projects
 - 21 (a) JRES fishing association..... 5,000
 - 22 (b) Peniemwan, Saputiw water tank..... 1,500



- 1 (c) Nukanap Ut..... \$ 3,000
- 2 (d) Fanmenew fishing project..... 5,000
- 3 (e) Other public projects..... 10,000
- 4 (6) Totiw public projects..... 4,000
- 5 (7) Other municipal needs..... 141,500"

6 Section 2. Section 4 of Public Law No. 7-35 is hereby amended
7 to read as follows:

8 "Section 4. Faichuk public projects. The sum of \$690,000,
9 or so much thereof as may be necessary, is hereby
10 appropriated from the General Fund of the Federated States
11 of Micronesia for the fiscal year ending September 30,
12 1992, for the purpose of funding public projects in
13 Faichuk, Chuuk State. The sum appropriated by this section
14 shall be apportioned as follows:

- 15 (1) Chuuk State Congressional Delegation
- 16 boat with motors..... \$ 16,000
- 17 (2) Other Faichuk public projects..... 674,000"

18 Section 3. This act shall become law upon approval by the
19 President of the Federated States of Micronesia or upon its becoming
20 law without such approval.
