CONGRESSIONAL BILL NO. 7-283, C.D.1

AN ACT

To further amend Public Law No. 7-35, Chuuk State public projects, as amended by Public Laws Nos. 7-43 and 7-44, by further amending section 1, as amended by Public Law No. 7-43, for the purpose of modifying the use of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 7-35, as amended by  
2 Public Law No. 7-43, is hereby further amended to read as follows:

3 "Section 1. Statewide public projects. The sum of  
4 \$400,000, or so much thereof as may be necessary, is hereby  
5 appropriated from the General Fund of the Federated States  
6 of Micronesia for the fiscal year ending September 30,  
7 1992, for the purpose of funding statewide public projects  
8 in the State of Chuuk. The sum appropriated by this  
9 section shall be apportioned as follows:

- 12 Program..... \$20,400
- 13 (2) Chuuk Red Cross..... 5,000
- 14 (3) Medical supplies and equipment..... 50,000

- 16 (5) Hall Islands Jr. High School..... 10,000
- 17 (6) Farmers Home Administration - Chuuk
- 18 office..... 7,000
- 19 (7) Mortlocks regional projects
- 20 (a) Oneop ice plant operating expenses.. 15,000
- 21 (b) Satawan ice plant operating
- 22 expenses..... 5,000

- 1 (8) Faichuk regional projects
- 2 (a) Polle Elementary School renovation.. \$24,000
- 3 (b) Paata project..... 16,000
- 4 (c) Tol municipal projects..... 20,000
- 5 (9) Weipat Jr. High School..... 10,000
- 6 (10) Chuuk State CIP supplement..... 122,600
- 7 (11) Parem project..... 5,000
- 8 (12) Faichuk Jr. High School..... 20,000
- 9 (13) Nama municipal projects..... 5,000
- 10 (14) Fanapanges municipal projects..... 5,000
- 11 (15) Canvasback medical program project..... 20,000"

12 Section 2. This act shall become law upon approval by the  
 13 President of the Federated States of Micronesia or upon its becoming  
 14 law without such approval.
