

AN ACT

To further amend Public Law No. 7-24, as amended by Public Laws Nos. 7-63 and 7-74, Pohnpei State public projects, by further amending sections 2 and 5, as amended by Public Laws No. 7-63 and 7-74, to modify the use of certain funds previously appropriated therein and to provide certain reporting requirements for the allottees of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 7-24, as amended by
2 Public Laws Nos. 7-63 and 7-74, is hereby further amended to read as
3 follows:

4 "Section 2. Madolenihmw and Kitti public projects. The
5 sum of \$875,000, or so much thereof as may be necessary, is
6 hereby appropriated from the General Fund of the Federated
7 States of Micronesia for the fiscal year ending September
8 30, 1992, for the purpose of funding public projects in
9 Madolenihmw and Kitti, Pohnpei State. The sum appropriated
10 by this section shall be apportioned as follows:

2 Section 2. Section 5 of Public Law No. 7-24, as amended by Public
3 Laws Nos. 7-63 and 7-74, is hereby further amended to read as follows:

4 "Section 5. All funds appropriated by this act shall be
5 allotted, managed, administered, and accounted for in
6 accordance with applicable law, including, but not limited
7 to, the Financial Management Act of 1979. The allottee of
8 the funds appropriated under subsections (6), (7), (8),
9 (9), (10), (11), (12) and (13) of section 1 of this act,
10 and of section 3, except subsections (5), (8) and (9) of
11 section 3 of this act, shall be the President of the
12 Federated States of Micronesia. The allottee of the funds
13 appropriated under subsection (1) of section 2 of this act
14 shall be the Meninkederlapalap of the Municipality of
15 Madolenihmw. The allottee of the funds appropriated under
16 subsection (2) of section 2 of this act shall be the
17 Lukenmoanlap of the Municipality of Kitti. The allottees
18 of the funds appropriated under section 2 of this act shall
19 submit detailed funds status and project status reports to
20 the Congress of the Federated States of Micronesia at the
21 beginning of each quarter of each fiscal year until the
22 funds appropriated thereunder are fully expended. The
23 allottee of the funds appropriated under subsection (15) of
24 section 1 and under section 4 of this act shall be the
25 Governor of Pohnpei State. The allottee of the funds

1 appropriated under subsection (1) of section 1 of this act
2 shall be the Pohnpei State PTA. The allottee of the funds
3 appropriated under subsection (2) of section 1 of this act
4 shall be the Mayor of Kolonia Town. The allottee of the
5 funds appropriated under subsections (3), (17) and (18) of
6 section 1 of this act shall be the Chief Magistrate of
7 Sokehs Municipality. The allottee of the funds
8 appropriated under subsections (4), (14), (16) and (19) of
9 section 1 of this act and under subsections (5), (8) and
10 (9) of section 3 of this act shall be the Pohnpei Community
11 Action Agency. The allottee of the funds appropriated under
12 subsection (5) of section 1 of this act shall be the
13 Luhkenkolwof of Sapwuahfik Municipality. The allottees
14 shall be responsible for ensuring that these funds, or so
15 much thereof as may be necessary, are used solely for the
16 purposes specified in this act, and that no obligations are
17 incurred in excess of the sum appropriated. The authority
18 of the allottees to obligate funds appropriated by this act
19 shall not lapse."
