

AN ACT

To further amend Public Law No. 18-70, as previously amended by Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, 19-41, 19-52, 19-73, 19-82, 19-101, 19-114, and 19-139, by amending sections 2 and 6 thereof, to change the use and lapse date of certain funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 18-170, as amended by
2 Public Laws Nos. 18-98, 18-112, 19-24, 19-41, 19-52, 19-73, 19-82,
3 19-101, 19-114, and 19-139, is hereby further amended to read as
4 follows:

5 "Section 2. Of the sum of \$5,100,000 appropriated by
6 this act, \$750,000 is apportioned for public projects
7 and social programs in the state of Yap.

10 Section 2. Section 6 of Public Law No. 18-70, as amended by
 11 Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, and 19-101
 12 is hereby further amended to read as follows:

13 "Section 6. Allotment and management of funds and lapse
 14 date. All funds appropriated by this act shall be
 15 allotted, managed, administered and accounted for in
 16 accordance with applicable laws, including, but not
 17 limited to, the Financial Management Act of 1979. The
 18 allottee shall be responsible for ensuring that these
 19 funds, or so much thereof as may be necessary, are used
 20 solely for the purpose specified in this act, and that
 21 no obligations are incurred in excess of the sum
 22 appropriated. The allottee of the funds appropriated
 23 under section 2 of this act shall be the Governor of Yap
 24 State EXCEPT THAT the funds appropriated under
 25 subsection 2(i) shall be the President of COM-FSM. The

1 allottee of funds appropriated under sections 3 and 4 of
2 this act shall be the President of the Federated States
3 of Micronesia or his designee EXCEPT THAT the funds
4 appropriated under subsections a, b, c, d, e, f, g, h,
5 i, j, k, l, m, n, o, s, t, u, v, w, x, ag, ah, aj, ap
6 and aq of section 3 this act shall be the Mayor of Lelu
7 Town Government or his designee; the funds appropriated
8 under subsections a, b, c, d, e, f and g of section
9 4(1), subsections 4(3)(b), (c), (d), (f) and (p) of this
10 act shall be the Pohnpei Transportation Authority, and the
11 funds appropriated under subsection 4(3)(t) shall be the
12 Luhkenmoanlap of Kitti. The allottee of funds
13 appropriated under subsections 5(1), 5(3) and 5(6), of
14 this act shall be the Governor of Chuuk State or his
15 designee. The allottee of funds appropriated under
16 subsection 5(2) of this act shall be the Mortlock
17 Islands Development Authority. The allottee of funds
18 appropriated under subsection 5(4) of this act shall be
19 the Southern Namoneas Development Authority. The
20 allottee of funds appropriated under subsection 5(5) of
21 this act shall be the Faichuk Development Authority.
22 The authority of the allottee to obligate funds
23 appropriated by this act shall lapse on September 30,
24 2018."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
