

THIRD CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FIRST SPECIAL SESSION, 1983 CONGRESSIONAL BILL NO. 3-75, C.D.1, C.D.2

AN ACT

To appropriate the sum of \$4,374,119 from the General Fund of the Federated States of Micronesia and the sum of \$6,545,974 from the United States Grant Special Fund for the fiscal year ending September 30, 1984, for the operations of the executive branch, legislative branch, National judiciary, Public Auditor, agencies of the National Government, and for special programs, contributions, grants, subsidies, and refunds of the National Government during fiscal year 1984; to establish employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Operating expenses of the executive branch. The
 2 sum of \$1,024,100, or so much thereof as may be necessary, is
 3 hereby appropriated from the General Fund of the Federated States
 4 of Micronesia, and the sum of \$4,523,574, or so much thereof as may
 5 be necessary, is hereby appropriated from the United States Grant
 6 Special Fund for the fiscal year ending September 30, 1984, for the
 7 operations of the executive branch of the National Government of
 8 the Federated States of Micronesia during fiscal year 1984. The
 9 sums appropriated by this section shall be apportioned as follows:

4 appropriated from the United States Grant Special Fund for the
5 fiscal year ending September 30, 1984, for the operations of the
6 National judiciary of the Federated States of Micronesia during
7 fiscal year 1984. The sums appropriated by this section shall be
8 apportioned as follows:

11 September 30, 1984, for the operations of independent agencies,
12 commissions, authorities, boards, bureaus, and other organizations
13 of the National Government of the Federated States of Micronesia
14 during fiscal year 1984. The sums appropriated by this section

20 (2) The number of positions authorized applies individually
 21 to each of the departments and offices of the executive and legisla-
 22 tive branches, the National judiciary, the Public Auditor, and to
 23 the agencies as provided in subsection (1) of this section, except
 24 that the President may transfer up to 12 positions between the
 25 departments and offices of the executive branch. This authoriza-

1 tion of positions covers all permanent employees, all contract
2 personnel whose employment extends for 1 year or more, and all
3 positions funded from United States federal programs. No funds may
4 be expended for unbudgeted positions.

5 Section 8. Reprogramming.

6 (1) The President or his designee may reprogram up to 10
7 percent to and from the funds appropriated to each of the subsec-
8 tions in section 1, and may reprogram up to 15 percent to and from
9 the funds appropriated in each of the paragraphs within the sub-
10 sections of section 1.

11 (2) The Speaker or his designee may reprogram up to 10
12 percent to and from the funds appropriated to each of the subsec-
13 tions in section 2, and may reprogram up to 15 percent to and from
14 the funds appropriated in each of the paragraphs within the sub-
15 sections of section 2.

16 (3) The Chief Justice or his designee may reprogram up to
17 15 percent to and from the funds appropriated in each of the sub-
18 sections in section 3.

19 (4) The Public Auditor may reprogram up to 15 percent to
20 and from the funds appropriated in each of the subsections in
21 section 4.

22 (5) Allottees of funds may reprogram up to 15 percent to
23 and from the funds appropriated in each of the paragraphs within the
24 subsections of section 5.

25 Section 9. Allotment and management of funds and lapse date.

1 All funds appropriated by this act shall be allotted, managed,
2 administered, and accounted for in accordance with applicable law,
3 including, but not limited to, the Financial Management Act of
4 1979, as amended. The allottee shall be responsible for ensuring
5 that these funds, or so much thereof as may be necessary, are used
6 solely for the purposes specified in this act, and that no
7 obligations are incurred in excess of the sum appropriated. The
8 authority of the allottee to obligate funds appropriated by this
9 act, except those appropriated by section 6(3), shall lapse as of
10 September 30, 1984.

11 Section 10. Effective date. This act shall become law upon
12 approval by the President of the Federated States of Micronesia or
13 upon its becoming law without such approval.
