CONGRESSIONAL BILL NO. 3-165, C.D.1,
C.D.2

AN ACT

To further amend Public Law No. 2-35, as amended by Public Laws Nos. 2-42 and 3-5, which appropriated the sum of \$637,600 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the purpose of funding public projects in the State of Ponape, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 2-35, as amended by
2 Public Laws Nos. 2-42 and 3-5, is hereby further amended to read as
3 follows:

4 "Section 1. Appropriation. The sum of \$637,600, or so much
5 thereof as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for the
7 fiscal year ending September 30, 1982, for the purpose of
8 funding public projects in the State of Ponape. The sum
9 appropriated shall be apportioned in the following manner:

- 10 (1) Kitti Municipality for transportation, infra-
11 structure, and farmer's aid
- 12 (a) Transportation equipment. \$15,000
13 (b) Channels, farm roads, classrooms, bridges,
14 water system, school supplies, economic development
15 projects assistance, and summer training 80,000
- 16 (2) Madolenihmw Municipality for transportation,
17 infrastructure, and farmers' aid
- 18 (a) Economic development projects, classrooms,
19 farm roads, causeway, and summer training. 20,000
20 (b) Sapwerek elementary classrooms 9,000
21 (c) Nansohli water system. 1,000
22 (d) Diadi water system. 1,000


