

AN ACT

To further amend Public Law No. 3-56, as amended by Public Laws Nos. 3-71, 4-8 and 4-14, by further amending section 1, as amended by Public Laws Nos. 3-71 and 4-8, to change the purpose for which funds were appropriated under subsections (8)(c), (8)(h) and (9) of section 1, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-56, as amended by
2 Public Laws Nos. 3-71 and 4-8, is hereby further amended to read
3 as follows:

4 "Section 1. The sum of \$789,700, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia
7 for the fiscal year ending September 30, 1985, for
8 the purpose of funding public projects in the State
9 of Truk. The sum appropriated herein shall be
10 apportioned as follows:

 - 14 (b) Purchase of Truk
15 dispensaries' medical supplies
