

AN ACT

To amend sections 2 and 3 of Public Law No. 4-93, Pohnpei State public projects, for the purpose of reapportioning certain funds; providing for new projects; clarifying the purpose for which funds are appropriated; exempting the funds apportioned to the Pohnpei State Development Fund from lapsing; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 4-93 is hereby amended  
2 to read as follows:

14 Section 2. Section 3 of Public Law No. 4-93 is hereby amended to  
15 read as follows:

16 "Section 3. All funds appropriated by this act shall be  
17 allotted, managed, administered, and accounted for in  
18 accordance with applicable law, including, but not limited  
19 to, the Financial Management Act of 1979. The allottee shall  
20 be the Governor of Pohnpei State for all the appropriations  
21 herein, except that the Pohnpei Community Action Agency shall  
22 be the allottee for appropriations under subsection (2) of  
23 section 2, the Menin Keder Lapalap of the Madolenihmw  
24 Municipal Government shall be the allottee for appropriations  
25 under subsection (1)(a) of section 2, the Luhken Menlap of the

1           Kitti Municipal Government shall be the allottee for appro-  
2           priations under subsection (1)(b) of section 2, the Chief  
3           Magistrate of Sokehs shall be the allottee for appropriations  
4           under subsection (3)(a) of section 2, the Kolonia Town Mayor  
5           shall be the allottee for appropriations under subsection  
6           (3)(b) of section 2, the Luhkenkolwof of Sapwuahfik shall be  
7           the allottee for all appropriations under subsection (3)(c)  
8           of section 2, and the Pohnpei Farmers Home Administration  
9           Office shall be the allottee for appropriations under  
10          subsections (1)(a)(xxix), (1)(b)(xxviii), and (4)(f) of  
11          section 2. The allottees shall be responsible for ensuring  
12          that these funds, or so much thereof as may be necessary, are  
13          used solely for the purposes specified in this act, and that  
14          no obligations are incurred in excess of the sum appropriated.  
15          The authority of the allottees to obligate all funds appro-  
16          priated by this act, except those appropriated under sub-  
17          section (4)(1) of section 2, shall lapse as of September 30,  
18          1987. The funds appropriated under subsection (4)(1) of  
19          section 2 shall not lapse."


