Public Law No. 6 - 43

AN ACT

To amend Public Law No. 6-10 by amending sections 1, 5 and 12 for the purpose of appropriating the sum of \$4,335,205 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, as supplemental funding for the executive branch, agencies of the National Government and other National Government programs, grants, subsidies, contributions, and refunds; by amending section 14 for the purpose of modifying employment ceilings; by amending section 16 for the purpose of modifying lapse dates; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 6-10 is hereby amended
2 to read as follows:

3 "Section 1. Operating expenses of the executive branch.
4 The sum of \$8,811,655, or so much thereof as may be
5 necessary, is hereby appropriated from the General Fund
6 of the Federated States of Micronesia for the fiscal
7 year ending September 30, 1990, for the operations of the
8 executive branch of the National Government of the
9 Federated States of Micronesia during fiscal year 1990.

10 As required by Public Law No. 5-119, the Congress of the
11 Federated States of Micronesia hereby declares that the
12 funding appropriated by this section is deemed to be
13 essential. The sum appropriated by this section shall be
14 apportioned as follows:

15 as may be necessary, is hereby appropriated from the
16 General Fund of the Federated States of Micronesia for the
17 fiscal year ending September 30, 1990, for the operations
18 of independent agencies, commissions, authorities, boards,
19 bureaus, and other organizations of the National Government
20 of the Federated States of Micronesia during fiscal year
21 1990. As required by Public Law No. 5-119, the Congress of


