

SIXTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

THIRD REGULAR SESSION, 1990

CONGRESSIONAL BILL No. 6-273, C.D.1

AN ACT

To appropriate the sum of \$1,800,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding statewide and other public projects in Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Sokehs, Kolonia, Sapwuahfik, Nukuoro, and
2 Kapingamarangi public projects. The sum of \$525,000, or so much
3 thereof as may be necessary, is hereby appropriated from the General
4 Fund of the Federated States of Micronesia for the fiscal year ending
5 September 30, 1990, for the purpose of funding certain public
6 projects in Sokehs, Kolonia, Sapwuahfik, Nukuoro, and Kapingamarangi,
7 Pohnpei State. The sum appropriated under this section shall be
8 apportioned as follows:

- 9 (1) Sokehs public projects and programs
- 10 (a) Municipal office operations..... \$ 44,000
- 11 (b) Sokehs civil engineer, housing and
12 transportation..... 7,600
- 13 (c) Fee for attorney retainer..... 10,000
- 14 (d) Sekere/Nanponmal road paving..... 15,000
- 15 (e) Tomwara/Soundau road..... 15,000
- 16 (f) Lewetik/Tamworoi road..... 50,000
- 17 (g) Waterline maintenance..... 8,400
- 18 (h) Capital water system extension..... 50,000

- 20 (3) Sapwuahfik programs and projects..... 25,000
- 21 (4) Nukuoro programs and projects..... 25,000
- 22 (5) Kapingamarangi programs and projects..... 25,000

2 Section 2. Madolenihmw and Kitti public projects. The sum of
3 \$425,000, or so much thereof as may be necessary, is hereby appro-
4 priated from the General Fund of the Federated States of Micronesia
5 for the fiscal year ending September 30, 1990, for the purpose of
6 funding certain public projects in Madolenihmw and Kitti, Pohnpei
7 State. The sum appropriated by this section shall be apportioned as
8 follows:

19 Section 3. Community Action Agency Block Grant for Nett, U,
20 Pingelap and Mokil public projects. The sum of \$350,000, or so much
21 thereof as may be necessary, is hereby appropriated from the General
22 Fund of the Federated States of Micronesia for the fiscal year ending
23 September 30, 1990, for the purpose of funding a Community Action
24 Agency Block Grant for projects and incentive program grants in Nett,
25 U, Pingelap and Mokil, Pohnpei State.

1 Section 4. Statewide public projects. The sum of \$500,000, or
2 so much thereof as may be necessary, is hereby appropriated from the
3 General Fund of the Federated States of Micronesia for the fiscal
4 year ending September 30, 1990, for the purpose of funding certain
5 statewide public projects in Pohnpei State. The sum appropriated by
6 this section shall be apportioned as follows:

23 Section 5. Allotment and management of funds and lapse date.
24 All funds appropriated by this act shall be allotted, managed,
25 administered, and accounted for in accordance with applicable

1 law, including, but not limited to, the Financial Management Act
2 of 1979. The allottee of the funds appropriated under paragraphs
3 (a), (b), (c) and (d) of subsection (1) of section 1 of this act
4 shall be the Chief Magistrate of the Sokehs Municipal Government.
5 The allottee of the funds appropriated under subsection (2) of
6 section 1 of this act shall be the Kolonia Town Mayor. The allottee
7 of the funds appropriated under subsection (3) of section 1 of this
8 act shall be the Luhkenkolwof of Sapwuahfik. The allottee of the
9 funds appropriated under subsection (4) of section 1 of this act
10 shall be the Chief Magistrate of the Nukuoro Municipal Government.
11 The allottee of the funds appropriated under subsection (5) of
12 section 1 of this act shall be the Chief Magistrate of the
13 Kapingamarangi Municipal Government. The allottee of the funds
14 appropriated under subsections (1) and (2) of section 2 and paragraph
15 (3)(a) of section 2 of this act shall be the Menin Keder Lapalap of
16 the Madolenihmw Municipal Government. The allottee of the funds
17 appropriated under paragraph (3)(b) of section 2 shall be the
18 Madolenihmw Municipal Government. The allottee of the funds
19 appropriated under subsections (4) and (5) of section 2 and paragraph
20 (6)(a) of section 2 shall be the Luhkenmenlap of the Kitti Municipal
21 Government. The allottee of the funds appropriated under paragraph
22 (6)(b) of section 2 shall be the Kitti Municipal Government. The
23 allottees of the funds appropriated under subsections (1), (2), (4)
24 and (5) of section 2 of this act and paragraphs (3)(a) and (6)(a) of
25 section 2 of this act shall submit detailed funds status and project

1 status reports to the Congress of the Federated States of Micronesia
2 at the beginning of each quarter of each fiscal year. The allottee
3 of the funds appropriated under paragraphs (e), (f), (g) and (h) of
4 subsection (1) of section 1; subsection (6) of section 1; section 3;
5 and subsection (8) of section 4 of this act shall be the Pohnpei
6 Community Action Agency; PROVIDED, however, that the funds appro-
7 priated under subsection (6) of section 1 of this act shall not be
8 allotted before October 1, 1990. The allottees shall be responsible
9 for ensuring that these funds, or so much thereof as may be necessary,
10 are used solely for the purposes specified in this act, and that no
11 obligations are incurred in excess of the sum appropriated. The
12 authority of the allottees to obligate funds appropriated by this act
13 shall not lapse until expended.

14 Section 6. Effective date. This act shall become law upon
15 approval by the President of the Federated States of Micronesia or
16 upon its becoming law without such approval.
