1. This Act may be cited as the Supplementary Appropriation (No. 1) Act 2007.

Authorisation of issue of \$150,000.00 from the Consolidated Fund

2. The issue from the Consolidated Fund is hereby authorised of a sum of \$150,000.00 to be applied for recurrent expenditure to the service of the year ending 31 December 2007.

3. The sum specified in section 2 shall be appropriated for the supply of the Heads of Expenditure in Column 1 of the Schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.

SUPPLEMENTARY APPROPRIATION (NO. 1) ACT 2007

EXPLANATORY MEMORANDUM

- 1. This Act charges upon the Consolidated Fund a sum, which is required for recurrent expenditure for the year ending December 2007.
- 2. The sum required is to provide for monies to be expended in excess of that sum which has already been appropriated by the Appropriation Act 2006.
- 3. The Act provides that this additional amount charged upon the Consolidated Fund shall be divided between and expended upon the services listed in the Schedule to the Act.
- 4. The Act is presented to the Maneaba ni Maungatabu in accordance with the requirements of section 109(3) of the Constitution.
