No. 3 of 1966.

## AN ORDINANCE

To confer certain powers on the Administrator in Council, and for other purposes.

(Assented to 14 FEB 1966 19 .)

Be it ordained by the Legislative Council for the Territory of Nauru, in pursuance of the powers conferred by the Nauru Act 1965, as follows:-

- Short Title. 1. This Ordinance may be cited as the <u>Executive</u>

  <u>Council Ordinance</u> 1966.
- Amendment of 2. The Ordinances specified in the first column Ordinances.

  of the First Schedule to this Ordinance are amended as respectively specified in the second column of that Schedule.

Citation of amended Ordinances.

3. Each Ordinance specified in the first column of the Second Schedule to this Ordinance, as amended by this Ordinance, may be cited in the manner specified in the second column of that Schedule opposite the reference to that Ordinance in the first column.

Exercise of powers etc., of Admini-strator in Council.

- 4.- (1.) Where it is provided by any other Ordinance that an act or thing is to be or may be done by the Administrator in Council, that act or thing is to be or may, as the case may be, be done by the Administrator acting in accordance with the advice of the Executive Council and not otherwise.
- (2.) The functions of the Executive Council include advising the Administrator in respect of the doing of such an act or thing.

Acts of 5. Where the Administrator states in an instru-Administrator not to be ment by which he does an act or thing to which the last called in question. preceding section applies that he is acting in accordance with the advice of the Executive Council,
