To enable the application of the Special Missions Privileges and Immunities Act to certain international organisations and their personnel and for purposes incidental thereto

Be it enacted by the Parliament of Nauru as follows:

PART I - PRELIMINARY

SHORT TITLE

1(1) This Act may be cited as the Special Missions Privileges and Immunities Amendment Act 1992

(2) In this Act the Special Missions Privileges and Immunities Act 1976 is referred to as the principal Act.

(3) The principal Act as amended by this Act may be cited as the Special Missions Privileges and Immunities Act 1976-1992.

AMENDMENT TO SECTION 2 OF THE PRINCIPAL ACT

2. Section 2 of the principal Act is amended by inserting the following definition before the definition "State" -

"International Organisation" means a body, incorporated or unincorporated, which is formed or constituted by representatives of states or of one or more other international organisations or

which is recognised by states as a bona fide international organisations and includes the United Nations, constituent organisations of the United Nations, the Asian Development Bank, the World Bank and the International Chamber of Commerce."

NEW SUB-SECTIONS 3(7) and (8)

3. The following sub-sections are inserted immediately after sub-section 6 of Section 3 of the principal Act -

" (7). Any part of the provisions of this Act and any part of the Convention may from time to time be extended by order of Cabinet, published in the Gazette, to any International Organisation and to such of its officers employees agents and contractors as are specified therein as if the International Organisation were a special mission and the officers employees agents or contractors were members, members of the staff, members of the administrative and technical staff, members of the service staff, the private staff, or the members of, a special mission as the case may be".

(8) An order made pursuant to the previous sub-section may be made for a particular time and may be amended repealed or varied at any time by further order of Cabinet published in the Gazette."
