Being an Act to amend various Acts so as to make certain administrative arrangements in relation to the appropriation of moneys and for related purposes,

MADE by the National Parliament.

**PART I - AMENDMENT OF THE *AUDIT ACT* 1989.**

**1. FINANCE (AMENDMENT OF SECTION 21).**

Section 21(2) of the *Audit Act 1989* is amended by repealing the words "which is, to the extent necessary, appropriated accordingly".

**PART II - AMENDMENT OF *CONSTITUTIONAL OFFICE-HOLDERS RETIREMENT BENEFITS ACT* 1986.**

**2. REPEAL AND REPLACEMENT OF SECTION 8.**

Section 8 of the *Constitutional Office-holders Retirement Benefits Act 1986* is repealed and is replaced with the following:-

**'8. PENSION TO BE PAID OUT OF CONSOLIDATED REVENUE FUND.**

A pension payable under Sections 4, 5, 6 or 7 of this Act shall be paid out of the Consolidated Revenue Fund."

**PART III - AMENDMENT OF THE *LOANS (OVERSEAS BORROWINGS) ACT* (CHAPTER 133).**

**3. REPEAL AND REPLACEMENT OF SECTION 4.**

Section 4 of the *Loans (Overseas Borrowings) Act* (Chapter 133) is repealed and is replaced with the following:-

**"4. MONEYS FOR REPAYMENT OF LOANS.**

All payments of principal and interest and other charges payable under a loan agreement shall be made out of the Consolidated Revenue Fund."

Section 4 of the *Loans (Overseas Borrowings) (No. 2) Act* (Chapter 133A) is repealed and is replaced with the following:-

**"4. MONEYS FOR REPAYMENT OF LOANS.**

All payments of principal and interest and other charges payable under a loan agreement shall be made out of the Consolidated Revenue Fund."

**PART V. - AMENDMENT TO *LOANS SECURITIES ACT* (CHAPTER 134).**

**5. CONDITIONS OF ISSUE (AMENDMENT OF SECTION 6).**

Section 6(2) of the *Loans Securities Act* (Chapter 134) is amended by repealing the words "which is to the necessary extent appropriated accordingly."

**6. PAYMENT OF JUDGEMENTS AGAINST THE STATE IN RESPECT OF STOCK (AMENDMENT OF SECTION 25).**

Section 25(2) of the *Loans Securities Act* (Chapter 134) is amended by repealing the words "which is to the necessary extent appropriated accordingly."

**7. PAYMENT (AMENDMENT OF SECTION 30).**

Section 30(b) of the *Loans Securities Act* (Chapter 134) is amended by repealing the words "which is to the necessary extent appropriated accordingly."

**8. PAYMENT (AMENDMENT OF SECTION 36).**

Section 36 of the *Loans Securities Act* (Chapter 134) is amended by repealing the words "which is to the necessary extent appropriated accordingly."

**9. REPEAL AND REPLACEMENT OF SECTION 41.**

Section 41 of the *Loans Securities Act* (Chapter 134) is repealed and is replaced with the following:-

**"41. MONEYS TO BE PAID OUT OF CONSOLIDATED REVENUE FUND.**

All money payable into the National Debt Sinking Fund under Section 38 or 40 shall be paid out of the Consolidated Revenue Fund."

**10. PAYMENT OF MONEY BORROWED, COST OF CONVERSION OF LOANS, ETC., (AMENDMENT OF SECTION 50).**

Section 50 of the *Loans Securities Act* (Chapter 134) is amended by repealing the words "which is to the necessary extent appropriated accordingly."

**PART VI - AMENDMENT OF *LOANS AND ASSISTANCE (INTERNATIONAL AGENCIES) ACT* (CHAPTER 132).**

**11. REPEAL AND REPLACEMENT OF SECTION 5.**

Section 5 of the *Loans and Assistance (International Agencies) Act* (Chapter 132) is repealed and is replaced with the following:-

**"5. MONEYS FOR REPAYMENT OF LOANS.**

All payments of principal and interest and other charges payable by the State under a loan agreement shall be made out of the Consolidated Revenue Fund."

**12. REPEAL AND REPLACEMENT OF SECTION 6B.**

Section 6B of the *Loans and Assistance (International Agencies) Act* (Chapter 132) is repealed and is replaced with the following:-

**"6B. MONEYS PAYABLE BY THE STATE.**

All charges payable by the State under a financial assistance agreement shall be paid out of the Consolidated Revenue Fund."

**13. SALARIES AND ALLOWANCES (AMENDMENT OF SECTION 6).**

Section 6(2) of the *Official Personal Staff Act* (Chapter 383) is amended by repealing the words "which is appropriated accordingly."

**PART VIII. - AMENDMENT OF *PAPUA NEW GUINEA UNIVERSITY OF TECHNOLOGY ACT* 1986.**

**14. BASIC FINANCE (AMENDMENT OF SECTION 35).**

Section 35(2) of the *Papua New Guinea University of Technology Act* 1986 is amended by repealing the words "which is, to the necessary extent, appropriated accordingly."

**PART IX. - AMENDMENT OF *UNIVERSITY OF PAPUA NEW GUINEA ACT* (CHAPTER 169).**

**15. BASIC FINANCE (AMENDMENT OF SECTION 35).**

Section 35(2) of the *University of Papua New Guinea Act* (Chapter 169) is amended by repealing the words "which is, to the necessary extent, appropriated accordingly."
