Appropriation (National Development Expenditure 2009) Act 2008.

Being an Act to grant and apply out of the Consolidated Revenue Fund a sum for National Development expenditure for the year ending 31 December 2009 and to appropriate the supplies granted for that year.

MADE by the National Parliament.

1. NATIONAL DEVELOPMENT EXPENDITURE OF K2,595,165,300.00.

(1) Subject to authorisation from the Minister, the Secretary for Treasury may issue out of the Consolidated Revenue Fund and apply for National Development expenditure for the year ending 31 December 2009 the sum of K2,595,165,300.00.

(2) Where additional grant funding is received from donors in the year ending 31 December 2009, these amounts may be issued out of the Consolidated Revenue Fund and be applied to National Development expenditure in that year with the approval of the Minister. All such amounts must be itemized by project and reported to the Parliament as part of the Final Budget Outcome.

2. APPROPRIATION.

Sums granted by the Act out of the Consolidated Revenue Fund for National Development expenditure for the financial year ending 31 December 2009 are appropriated for the approved projects to be implemented by Agencies expressed in the Schedule in relation to the financial year ending 31 December 2009.

3. ADJUSTMENT OF APPROPRIATION AS BETWEEN PROJECTS.

Where there is insufficient appropriation to meet Government expenditure:

- (a) the Secretary for Treasury may direct the re-allocation of any unexpended appropriation under development expenditure to other development expenditure; and
- (b) in the event that there are agreed savings identified under any other Appropriation Acts of 2009 the Secretary for Treasury may direct the re-allocation of these unexpended amounts to development expenditure; and
- (c) the total amount of all re-allocations authorised under this section shall not exceed a sum of K259,516,530.00.00; and

- (d) where an amount appropriated under Division 229 is being transferred to the agency responsible for delivering the activity for which the amount is appropriated, this transfer will not count towards the total identified in Paragraph (c).

4. IMPACT OF CHANGES BY DONORS.

(1) K1,169,300,000 is expected to be funded from grants (K974,300,000) from donors and concessional loans (K195,000,000). In the event that funds are not forthcoming for a project, those funds cannot be issued from the Consolidated Revenue Fund.

(2) Where an amount of funding, provided by a donor agency, is re-allocated to another program by that donor without a request from the PNG Government, this amount will not be considered to count towards the re-allocation limit identified in Section 3(c). However, the donor agency must report this circumstance to the Secretary for Treasury, who must ensure that all such transfers are reported to the Parliament as part of the Final Budget Outcome.

5. DIRECTION TO BE AVAILABLE TO AUDITOR-GENERAL.

A copy of each direction under Section 3 shall be made available to the Auditor-General as soon as practicable after the end of each quarter of the financial year ending 31 December 2009.

6. DIRECTION FOR EXPENDITURE APPROPRIATED TO TRUSTS.

(1) K479 million of the amount appropriated in this Act is to be immediately transferred from the Divisions where they have been appropriated to Trust Accounts identified for the approved projects expressed in Schedule 2 in order that the sums can be paid into Trust Accounts under Section 16 of the *Public Finances (Management) Act 1995*. Where a Trust Account specified in Schedule 2 does not exist, a new trust account is to be established by the Minister for Finance under Section 15 of the *Public Finances (Management) Act 1995* and the transfer will take place immediately on the establishment of the Trust Account. In the event that the amounts expressed Schedule 2 are not transferred, the appropriation will lapse and the amounts will be returned to the Consolidated Revenue Fund. These funds cannot be utilized or transferred for any other purpose.

(2) The K356 million directed to the District Services Improvement Program Trust Account must be split equally, with an amount of K4 million to be allocated and expended in each of the 89 districts. The funds should be used for the development or purchase of district housing and office buildings.

(3) The K80 million directed to the National Agriculture Development Plan Trust Account must be used solely for the purpose of funding smallholder agriculture projects.
