Being an Act to amend the *Customs Tariff Act 1990,*

MADE by the National Parliament to come into operation on 1 January 2000.

**AMENDMENT OF SCHEDULE 1.**

Schedule 1 of the Principal Act is amended by repealing the Tariff classifications of the items under the heading "Previous Tariff Classifications" in the Table below and -

- (a) replacing them with the Tariff Classifications in the heading "New Tariff Classifications" opposite; and
- (b) applying to each the Description and Tariff Rate opposite:-
