Customs Tariff (Budget Provisions) Act 1993.

Being an Act to amend the *Customs Tariff Act 1990*,

MADE by the National Parliament to be deemed to have come into operation on 16 November 1993.

1. AMENDMENT OF SCHEDULE 1.

(1) Schedule 1 to the Principal Act is amended -

- (a) by repealing the rates of duty of each of the Tariff numbers specified in Schedule A to this Act and replacing them with the rates of duty specified opposite that Tariff number in Schedule A to this Act; and
- (b) by repealing the Tariff Items specified in Column (1) of Schedule B to this Act and replacing them with the Tariff Items specified in Column (2) opposite.

(2) Where in Schedule A to this Act a rate of duty is expressed in relation to a four figure Tariff number, that rate of duty applies to all items in Schedule 1 to the Principal Act commencing with these four figures and Schedule 1 to the Principal Act is amended accordingly.
