Excise Tariff (Amendment) Act 2022,

Being an Act to amend the *Excise Tariff Act 1956*,

MADE by the National Parliament to come into operation in accordance with a notice published in the National Gazette by the Head of State, acting with, and in accordance with, the advice of the Minister for Treasury.

DUTIES ON EXCISE (AMENDMENT OF SCHEDULE 1).

Schedule 1 of the Principal Act is amended by repealing the excise tariff items, description of the goods and rate of excise duties shown in the Schedule and replacing them with the excise tariff items, description of goods and the rate of excise duties as shown below -


