

LAND (SAMARAI IMPROVEMENT CONDITIONS) REGULATIONS, 1931.⁽¹⁾

1. These Regulations may be cited as the *Land (Samarai Improvement Conditions) Regulations, 1931.*⁽¹⁾

2. The improvements to be erected and maintained under the provisions of Section 34 (1.) of the *Land Ordinance, 1911-1927,*⁽²⁾ in respect of allotments in the Town of Samarai shall be of not less value than set out in Schedule 2 hereof in respect of each allotment.

3. The Regulations set out in Schedule 1 hereof are hereby repealed.
