

ORDINANCE INTERPRETATION ORDINANCE, 1940.⁽¹⁾

No. 12 of 1940.

An Ordinance to amend the "Ordinance Interpretation Ordinance, 1911-1939."

BE it ordained by the Legislative Council for the Territory of Papua, in pursuance of the powers conferred by the *Papua Act, 1905-1940*, as follows:—

1.—(1.) This Ordinance may be cited as the *Ordinance Interpretation Ordinance, 1940.*⁽¹⁾ Short title and citation.

(2.) The *Ordinance Interpretation Ordinance, 1911-1939*, is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance as amended by this Ordinance may be cited as the *Ordinance Interpretation Ordinance, 1911-1940*.

4.⁽³⁾ Section Six of the Principal Ordinance is amended by omitting the word "Lieutenant-Governor" (wherever occurring) and inserting in its stead the word "Administrator". Evidence of date of assent or notification of assent.

7.⁽³⁾ Section Twenty-eight of the Principal Ordinance is amended by omitting the words "Lieutenant-Governor or by the Lieutenant-Governor" and inserting in their stead the words "Administrator or by the Administrator". Proclamations judicially noticed.

(1) Particulars of this Ordinance are as follows:

(2) Sections 2, 3, 5, 6 and 8 amend the *Ordinance Interpretation Ordinance, 1911-1939*, and the amendments so made are incorporated in the *Ordinance Interpretation Ordinance, 1911-1940*.

(3) The amendments made by Sections 4 and 7 are incorporated in the *Ordinance Interpretation Ordinance, 1911-1940*. These Sections have, however, been printed as part of the *Ordinance Interpretation Ordinance, 1940*, in order that the text of Sections 6 and 28 of the *Ordinance Interpretation Ordinance, 1911-1939* (referred to in Section 9 of the *Ordinance Interpretation Ordinance, 1940*) may be ascertained.

LAWS (ADOPTION AND INTERPRETATION)—

Saving of certain provisions.

9. Sections Six and Twenty-eight of the Principal Ordinance shall continue to apply to all Ordinances ordained and Proclamations and Orders made or purporting to have been made prior to the commencement of this Ordinance as if this Ordinance had not been ordained.
