REVOCATION OF APPOINTMENT AND APPOINTMENT OF MEMBERS OF CHILDREN'S COURTS

I, WILLIAM JOHN FRANCIS KEARNEY, Secretary for Law, a delegate of the High Commissioner, by virtue of the powers conferred by Section 32(c) of the *Child Welfare Act 1961*, as amended to date, and all other powers me enabling, hereby—

- (a) revoke the appointment of each member of the Port Moresby Children's Court specified in Column 1 of Schedule 1 as contained in a notice dated and published as set out in Column 2 opposite to the name of that member; and
- (b) revoke the appointment of the member of the Samarai and Alotau Children's Court specified in Column 1 of Schedule 2 as contained in a notice dated and published as set out in Column 2 opposite to the name of that member; and
- (c) revoke the appointment of each member of the Kieta Children's Court specified in Column 1 of Schedule 3 as contained in a notice dated and published as set out in Column 2 opposite to the name of that member; and
- (d) revoke the appointment of the member of the Popondetta Children's Court specified in Column 1 of Schedule 4 as contained in a notice dated and published as set out in Column 2 opposite to the name of that member; and
- (e) appoint each person specified in Column 1 of Schedule 5 to be a member of the Children's Court specified in Column 2 and set out opposite the name of that person.
