## Pure Food Act 1952

## Pure Food Standards (Amendment) 1976,

Being an amendment to Standards set under Section 5A of the Pure Food Act 1952, dated 10th May, 1974 and notified in Government Gazette No. 42 of 17th May, 1974,

MADE by the Minister for Health.

### NEW SECTION 35A.

After Section 35 of the Principal Standards, the following section is inserted:-

- "35A.—PEANUT BUTTER.
- (1) Peanut butter and peanut paste are the products prepared from-
- (a) sound peanuts of one or more varieties that shall be roasted, shelled, cleaned and finely ground in accordance with the best commercial practice; and
- (b) salt added at the time of grinding.
- "(2) Peanut butter or peanut paste shall contain-
  - (a) not more than three parts per centum of moisture; and
  - (b) not less than 25 parts per centum of protein; and
  - (c) not less than 45 parts per centum of oil.
- "(3) Peanut butter or peanut paste-
  - (a) shall be free from rancidity; and
  - (b) shall be free from foreign matters; and
  - (c) shall be of smooth, creamy consistency; and
  - (d) shall have a palatable flavour; and
  - (e) shall show no excessive separation of oil.

"(4) Peanut butter or peanut paste shall conform with the standards obtained by analytical determination made in accordance with the recommendation of the International Organization for Standardization.".
