Customs Tariff 1959**EXEMPTION FROM DUTY**

I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 5 of the *Customs Tariff 1959* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby—

- (a) revoke the notice of Exemption from Duty dated 17th January, 1967 and published in *Gazette* No. 5 of 26th January, 1967; and
- (b) exempt from duty the goods specified in the Schedule subject to the condition that the exemption be reviewed on 1st July, 1969 or as soon as possible thereafter.

SCHEDULE

Reeled paper, paper sheets and boards which are declared to be and which the Comptroller of Customs is satisfied are, imported solely for the purpose of use in the manufacture of reading books, school books, text books, booklets, pamphlets and stationery.
