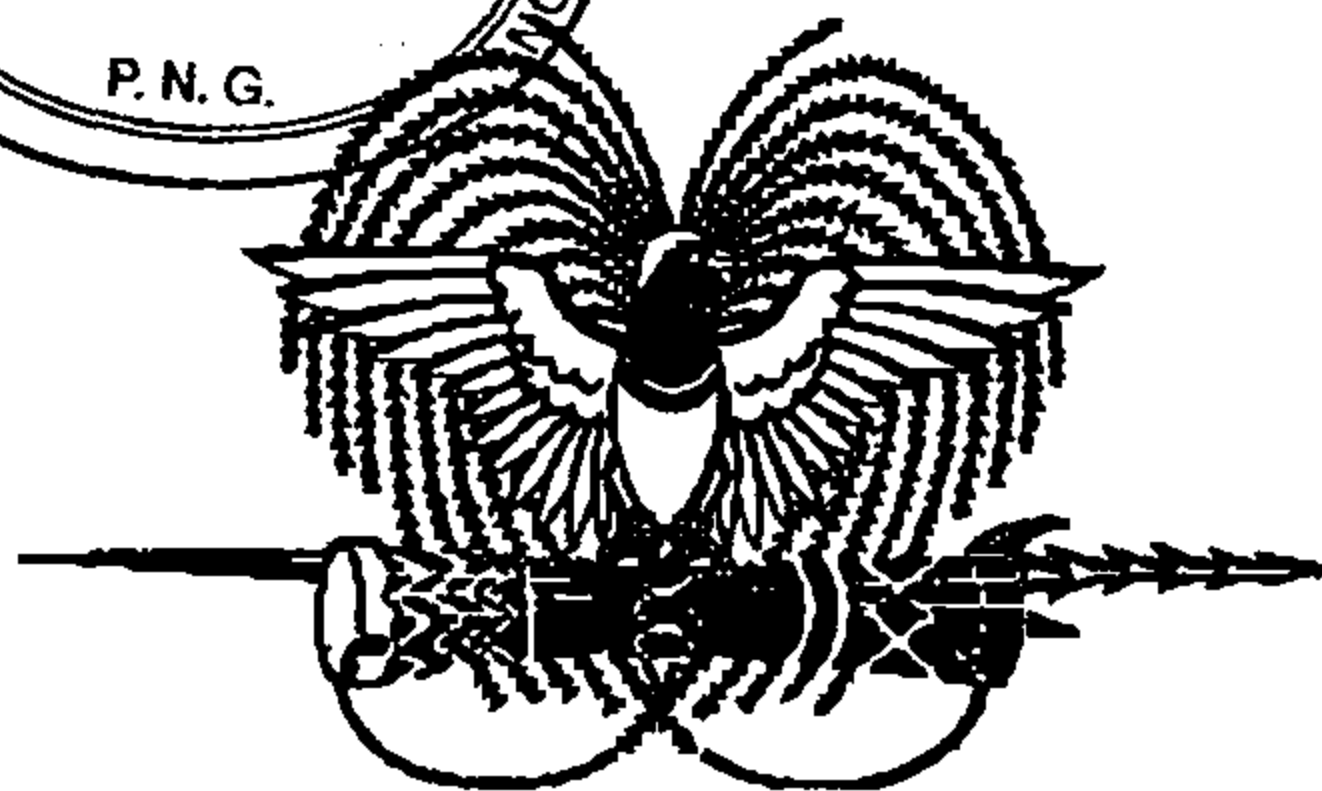

Forestry (Private Dealings) Act (Chapter 217)

DECLARATION OF LOCAL FOREST AREA

I, Jack Genia, Minister for Forests, by virtue of the powers conferred by Section 4(1) of the *Forestry (Private Dealings) Act (Chapter 217)* and all other powers me enabling, and being satisfied that—

(a) it is proper to do so having regard to:—

- (i) the interests of the owners by custom of the timber in any land (including their interests in having their land cleared and so enabling agricultural development to take place on the Land); and
- (ii) the national interests; and
- (iii) the prospects for the economic exploitation of the timber; and

(b) the area is one suitable for exploitation under the Act,

hereby declare the area specified in the Schedule to be a Local Forest Area for the purpose of the Act.

SCHEDULE

Boundary Description

Robinson River L.F.A.

An area known as Robinson River Local Forest Area (proposed) approximately of 39 800 hectares situated in the Milinches of Domara south-west, south-east, north-west north-east and Milinches of Lava south-east north-west in the Fourmil of Abau all in the Central Province commencing at Doma village and Liba River bounded by unsurveyed line bearing 289 degrees for the total distance of 13 000 metres to Babauguina Plantation and the Babauguina River thence bounded by the said Babauguina River upstream for approximately 15 000 metres to thence along the tributary for approximately 1 000 metres to the ridge top thence by unsurveyed line bearing 180 degrees for total distance of approximately 43 000 metres Bonua River thence bounded by the said Bonua River downstream generally south-east south-westerly for approximately 21 500 metres there by unsurveyed line bearings 291 degrees for approximately 15 000 metres to the Liba River thence bounded by 11 000 metres to the point of commencement and be said several dimensions a little more or little less.

SCHEDULE*Boundary Description***Aria Vanu Local Forest Area Block Three (3)**

An area of approximately of 34 086 hectares situated in the Milinches of Talawe north-east and south-east Rein north-west and south-west in the Fourmil of Roualt all in the Kimbe Sub District all in the West New Britain Province commencing at the left bank of Gaho River and the Highwater Mark of Bismark Sea thence bounded by the said Gaho River upstream generally south-westerly, for approximately 40 500 metres to its source thence bounded by un-surveyed line bearing 203 degrees for approximately 7 900 metres to the ridge top thence along the ridge top for approximately 2 000 metres to the source of the tributary thence bounded by the said tributary downstream generally south-southerly for approximately 17 000 metres to its confluence with Aria River thence bounded by the said Aria River downstream for approximately 34 000 metres to the right outlet of said Aria River and Highwater Mark of Bismark Sea aforesaid thence bounded generally south-easterly by the said highwater mark for an approximately distance of 6 000 metres to the point of commencement and be the said several dimensions a little less or little more and most boundaries natural and the only bearing magnetic.
