INDEPENDENT STATE OF PAPUA NEW GUINEA

AMENDMENTS TO THE PROPOSED LAW TO ALTER THE ORGANIC LAW ON PROVINCIAL GOVERNMENTS AND LOCAL-LEVEL GOVERNMENTS

MR Bernard Narokobi, MP, Leader of the Opposition: To move:—

1. Page 1, Clause 1, Amendments of Section 33A.

Clause 1 is amended by:—

- (a) in Subsection (2)(a) by inserting after the word "Committee" the following words "and in his absence, he shall appoint a Member under this Subsection of his choice to be the Chairman for a meeting"; and
- (b) deleting Paragraph (b), (c) and (d).

2. Page 1, Clause 2, Amendments of Section 95A.

Clause 2 is amended by:—

- (a) in Subsection (a) by deleting Subsection (1) and substituting it with the following:—

"(1) For each year, the National Government shall:—

- (a) make a District Support Grant of not less than K800,000.00 in respect of each Open Electorate:—
- (i) one half of which shall be for the purpose of funding the establishment or the improvement of District and Local-level Government centres; and
- (ii) one half of which shall be for the purpose of funding the rural action programme and the urban rehabilitation programme; and
- (b) make available to a Member representing an electorate an amount of K200,000.00 to be used in a manner and purpose as he determines from time to time and it shall be fully accounted for under an Act of Parliament"; and

- (b) in Paragraph (b):—

- (i) by amending Subsection (5)(b)(ii) by deleting the words "referred to in Subsection (6)" after the word "Parliament"; and
- (ii) deleting Subsection (6).

3. Page 2, Clause 3, New Section 95B.

Clause 3 is amended in Subsection (2) by deleting the amount "K300,000.00" and substituting it with "K1,000,000.00".
