DECLARATION OF NATIONAL EMERGENCY

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 228(1) of the Constitution and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby declare the existence of a National Emergency in relation to the Sandaun Province with effect on and from 18th July, 1998.

Emergency (General Powers) Regulation 1998

APPOINTMENT OF CONTROLLER

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 3 of the Emergency (General Powers) Regulation 1998, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby appoint—

- (a) the Commissioner for Police to be the Controller; and
- (b) the Director, National Disaster Centre and the Provincial Administrator appointed under Section 73(2) of the *Organic Law on Provincial Governments and Local level Governments* in relation to East Sepik Province, to be the Deputy Controllers,

for the purposes of the Emergency (General Powers) Regulation 1998.

CALL-OUT TO PROVIDE ASSISTANCE TO THE CIVILIAN AUTHORITIES
