**EXEMPTION FROM IMPORT DUTY**

**Citizenship Act (Chapter 12)**

**REVOCATION AND APPOINTMENT OF CHAIRMAN, DEPUTY CHAIRMAN AND PERMANENT MEMBERS OF THE CITIZENSHIP ADVISORY COMMITTEE**

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Sections 75 of the Constitution and 10(3) of the Citizenship Act (Chapter 12), and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Permanent Parliamentary Committee hereby:—

- (a) revoke the appointment of David Basua, a member of the Parliament, as a permanent member and Chairman of the Citizenship Advisory Committee and Ajax Eeli Bia, a member of the Parliament, as permanent member and Deputy Chairman of the Citizenship Advisory Committee; and
- (b) revoke the appointment of Peter Tsiamalili as a permanent member of the Citizenship Advisory Committee; and
- (c) appoint Stahl Musa, a member of the Parliament, to be a permanent member and Chairman of the Citizenship Advisory Committee; and
- (d) appoint Alfred Kalia, a member of the Parliament, to be a permanent member and Deputy Chairman of the Citizenship Advisory Committee; and
- (e) appoint Evoa Lalatute to be permanent member of the Citizenship Advisory Committee.

**Building Act (Chapter 301)**

**REVOCATION OF APPOINTMENT AND APPOINTMENT OF MEMBERS OF THE MILNE BAY PROVINCIAL BUILDING BOARD**
