*Public Services (Management) Act 1995*

### REVOCATION OF ACTING APPOINTMENT AND APPOINTMENT OF DEPARTMENTAL HEAD

*Customs Tariff Act 1990***EXEMPTION FROM IMPORT DUTY**

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the *Customs Tariff Act 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from import duty the new, used, modified and/or refurbished goods comprising an oil refinery and the other associated and ancillary goods, materials, assets, plant, equipment, consumables and spare and replacement parts and related expenses (other than goods and equipment that are not an integral part of the refinery and that are available to the refiner in Papua New Guinea as required by and in accordance with Clause 12.1 of the Project Agreement made 29th May, 1997 between the Independent State of Papua New Guinea and InterOil Limited and EP InterOil Ltd.,) that will be imported into Papua New Guinea for the purposes of implementing the refinery to be constructed at Napa Napa provided for in the said Project Agreement being goods—

- (a) that shall be imported specifically for the purposes of the construction and commissioning of the refinery during the period until the commencement of Commercial Operations as defined in the said Project Agreement after successful completion of performance and reliability trials and that shall be incorporated in the construction and fabrication of the said refinery as the property of the refiner and/or the developer; or
- (b) that shall otherwise be imported for a period of two years after commencement of Commercial Production be imported into Papua New Guinea by and/or retained by the refiner and/or developer or either of them for use in or in conjunction with the construction and/or commissioning and/or operation of the refinery and/or as consumables and/or as spare or replacement parts therefore, being the property of the refiner and/or the developer held or used in connection with or for the purposes of the construction, commissioning and operation of the said refinery and its associated and ancillary facilities and operations.
