## EXEMPTION FROM REVOCATION OF EXEMPTIONS

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1) of the *Customs Tariff Act 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby, with effect on and from 21st April, 1999, exempt from the revocation of exemptions dated 21st April, 1999 and published in *National Gazette* No. G53 on 22nd April, 1999 the following:—

- "(e) exemptions published in *National Gazette* No. G24 of 10th March, 1995 in respect of goods imported for—
- (i) the Lae Mackerel Cannery construction, and set up and processing, manufactory and canning of mackerel fish by Pacific Cannery Pty Ltd;
  - (ii) the Lae Cement factory construction and operation in accordance with and for the period of exemption covered in their respective Agreement.
- (f) exemption published in *National Gazette* No. G21 of 18th March, 1996 in respect of goods imported by RD Tuna Cannery and RD Fishing for the Madang Tuna Cannery construction and operation in accordance with and for the period of exemption covered in the Agreement"

## REVOCATION OF APPOINTMENT AND APPOINTMENT OF BOARD CHAIRMAN AND DIRECTORS OF TELIKOM PNG LIMITED

The revocation and appointment of the Chairman, Deputy Chairman and Directors take effect forthwith commencing 30th June, 1999 and for a period not exceeding five years.
