**NOTICE OF ISSUE OF NEW PAPUA NEW GUINEA SILVER JUBILEE COMMEMORATIVE BANKNOTES**

I, L. Wilson Kamit, Governor of the Bank of Papua New Guinea, by virtue of the powers conferred by Section 61(2) of the *Central Banking Act 2000*, hereby give notice of the forthcoming issue of the new Papua New Guinea Silver Jubilee Banknotes in 2 kina, 5 kina, 10 kina, 20 kina and 50 kina Denominations.

These banknotes retain all the existing design elements, the size and the substrates of the existing banknotes and incorporate the same security features. One significant modification is the over printing of the Papua New Guinea Silver Jubilee logo in full colour on the front of all the notes viz:—

K2—logo appears on the left of the National Crest below the denomination figure 2.

K5—logo appears on the lower front right of the note between the water mark, and the serial numbers.

K10—logo appears on the front left of the National Crest below the denomination figure 10.

K20—logo appears on the front left of the National Crest below the denomination figure 20.

K50—logo appears on the top front of the note between the words Papua New Guinea, the National Crest and the National Parliament design.

These banknotes will become legal tender on 15th September, 2000.
