3. The parties have mutually recognized the serious administrative problems faced by the Department of Health, and in a bid to avoid any industrial action, the parties pledge to work together in consultation with Department of Personnel Management and under the auspices of the Chairman of Public Services Conciliation and Arbitration Tribunal in order to finalize implementation of this MOU on or before 1st February, 2006.
