## **APPOINTMENT OF ACTING PRIME MINISTER**

I, Grand Chief Sir Paulias Matane, GCL., G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 4(2) of the *Prime Minister and National Executive Council Act 2002*, and all other powers me enabling, acting with, and in accordance with, the advice of the Prime Minister, a delegate of the National Executive Council, hereby:—

- (a) appoints Puka Temu, a Minister, to be the Acting Prime Minister in the absence overseas of the Deputy Prime Minister until the Prime Minister or the Deputy Prime Minister returns to the country; and
- (b) appoints Sir Rabbie Namaliu, a Minister, to be the acting Prime Minister during any period, other than the period specified in Paragraph (a), when both the Prime Minister and the Deputy Prime Minister are unavailable to perform the functions of the Prime Minister.

CONSTITUTION

AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, Michael Thomas Somare, Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 29th August, 2002 and published in *National Gazette* No. G138 of 29th August, 2002, as amended:—

(a) in Schedule 1 (Prime Minister):—

(i) In Column 3, by inserting after Paragraph (k) the following:—

“(l) National Narcotics Control Board”; and

(ii) In Column 4 by inserting after “*National Name Protection Act* (Chapter 10)” the following:—

“*National Narcotics Control Board Act 1992*”; and

(b) in Schedule 18 (Minister for Internal Security):—

(i) In Column 3, by deleting the following:—

“(c) National Narcotics Control Board”; and

(ii) In Column 4 by deleting “*National Narcotics Control Board Act 1992*”,

with effect on and from 12th October, 2005.
