**CIVIL AVIATION SAFETY AUTHORITY OF PAPUA NEW GUINEA****CLASSIFICATION OF AIRSPACE**

I, Wilson Sagati, acting Director of Civil Aviation, in accordance with Rule Part 71.101 hereby classify the following classes of airspace in accordance with ICAO classification of airspace that are to be used in the Port Moresby Flight Information Region with their operating restrictions, in the interests of aviation safety.

**Class A**

IFR flights only are permitted; all flights are provided with air traffic control service and are separated from each other.

**Class C**

IFR and VFR flights are permitted, all flights are provided with air traffic control services and IFR flights are separated from other IFR flights and from VFR flights. VFR flights are separated from IFR flights and receive traffic information respect to other VFR flights, and traffic avoidance advice or requested.

**Class F**

IFR and VFR flights are permitted, only IFR flights receive air traffic advisory services and all flights should receive flight information service if request.

Any person with a bona fide interest in airspace may apply to the Director for a designation or classification of airspace in accordance with Rule Part 71.7.
