NOTICE OF EXEMPTION

Consolidated Contractors (Company) Ltd is a contracting company to the PNG LNG Project contracted for the Komo Airport Expansion in the Southern Highlands Province. The company wishes to engage the services of experienced skilled and semi-skilled non-citizens who are required urgently in the Construction Phase of the Project.

These exemptions are granted in accordance to Section 51(3) of the *Employment of Non-citizens Act 2007* to the above mentioned in the interest of the nation and for a good cause in view of the LNG Projects contribution to the economic, up skilling and human resource development and infrastructures development of the country.

The exemptions are granted from 3rd August, 2011 to 3rd August, 2013.

Specific conditions placed against the exemptions are:—

- (1) For the company to pay a fee of K3000.00 for each employee to the Department of Labour & Industrial Relations;
- (2) For the company to register all non-citizen employees that require registration with a professional body;
- (3) For the company to provide employment opportunities (decent work, fair pay, promotions etc) to citizens;
- (4) For the company to provide opportunities for human resources development and skills training to its employees.
- (5) Non English speaking countries to show evidence of English proficiency for applicants; and
- (6) The company to provide data relating to foreign employment to the Department for purposes of work permits inspections.
