**NOTICE OF REFERAL OF JUDGE TO TRIBUNAL AND HEAD OF STATE TO APPOINT A TRIBUNAL TO INVESTIGATE ALLEGED BREACH OF SECTION 5(1) OF THE *JUDICIAL CONDUCT ACT 2012***

To: Sir Michael Ogio, G.C.M.G., K.St.J., Governor-General.

I, Jeffrey Nape, CMG, MP., Speaker of the National Parliament, by virtue of the powers conferred by Section 5(2) of the *Judicial Conduct Act 2012* and all other powers me enabling:—

- (a) having appeared to Parliament that a Judge failed to disqualify himself as required under Section 5(1)(a) of the *Judicial Conduct Act 2012* in proceedings Supreme Court Reference No. 1 of 2012; and
- (b) Parliament in the exercise of its powers conferred on it under Section 5(2) of the *Judicial Conduct Act 2012* by motion moved in Parliament dated 4th April, 2012 and duly approved hereby refer Chief Justice Salamo Injia for investigation by a Tribunal and refer to the Head of State to appoint and establish a Tribunal to:—
  - (i) to investigate the allaged breach of Section 5(2) of the *Judicial Conduct Act 2012* by Chief Justice Salamo Injia; and
  - (ii) provide a report back to Parliament upon completion of its inquiry.
