Customs Tariff Act 1990

EXEMPTION FROM IMPORT DUTY

I, Sir Michael Ogio, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9 of the *Customs Tariff Act 1990*, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt the rate of import duty:—

- (a) on all goods as agreed under the Interim Economic Partnership Agreement (IEPA) entered into between the Papua New Guinea and the European Union (EU) as specified in Schedule 1, except those goods not mentioned in Schedule 1; and
- (b) on all goods as agreed under The Melanesian Spearhead Group Trade Agreement (MSGTA) Negative List as specified in Schedule 2, except Mackerel (HS CODE 1604.15.00), Beet sugar (HS CODE 1701.12.00), Cane sugar (HS CODE 1701.13.00), other Cane sugar (HS CODE 1701.14.00), Salt packaged in containers and bags weighing less than 25kg (HS CODE 2501.00.10) and other salt (HS CODE 2501.00.20), with effect on and from the date of publication of this instrument in the *National Gazette*.
