Employment of Non-citizens Act 2007

NOTICE OF EXEMPTION

I, Mark Maipakai (MP) Minister for Labour and Industrial Relations in exercise of the powers conferred on me under Section 51 (1) of the *Employment of Non-citizens Act 2007* do hereby exempt the following non-citizens employees of SP Brewery from the requirement to hold a work permit. In addition the non-citizen employees are also exempted from the requirement to comply with Sections 17(1), (2) and 13 (1), 13.2 (a), & (a) of the "*Employment of Non-citizens Act 2007*".

SP Brewery Ltd a company wishes to engage the services of experienced non-citizens who are required urgently in the expansion phase of facilities in Port Moresby and Lae. The company has brewing facilities in Lae, Morobe Province and in Port Moresby, National Capital District.

The exemptions granted in accordance to Section 51 of the Employment of Non-Citizens Act 2007 are always in the interest of the nation and for a good cause, in view of the company's contribution to the country's development in terms of economic and human resource development.

The exemptions are granted from 20th November 2012 to 20th May 2013.

Specific conditions placed against the exemptions are:-

- (1) For the company to pay a fee of K11,000.00 for the 22 employees to the Department of Labour & Industrial Relations;
- (2) For the company to register all non-citizen employees that require registration with a professional body;
- (3) For the company to provide employment opportunities (decent work, fair pay, promotions etc) to citizen workers;
- (4) For the company to provide opportunities for human resource development and skills training to its employees.
