## **WITHDRAWAL OF SECTION 32 FINANCIAL POWERS AND FINANCIAL DELEGATES FOR SOUTHERN HIGHLANDS PROVINCIAL ADMINISTRATOR**

I, Steven Gibson, Acting Secretary of Finance, by virtue of the powers conferred by both Section 4 and Section 32(1) of the *Public Finances (Management) Act 1995* and by all other powers enabling me, hereby:

1. Revoke the Section 32 Financial Powers for the Provincial Administrator and the Financial Delegates to approve the requisitions of all classes expenditures, of grants, royalties, equities and other Project Development Funds for Southern Highlands Provincial Government;
2. The Financial Powers of Section 32 Officer and Financial Delegates to approve requisition of all classes of expenditures, grants, royalties, equities and other Project Development Funds for Southern Highlands Provincial Government is now revert back to Department of Finance;
3. All claim proposals for DSIP Grants, Project funds and various grants for the above province be now forwarded to Finance Department for final vetting and approval for payments;
4. For the smooth operation of the administration the Provincial Treasurer has to facilitate the interim arrangement to sign all the requisitions up to a limit of K10,000 only on the Recurrent Budget as Section 32 Officer;
5. An Officer who willfully refuses or neglects to comply with this direction is guilty of an offence under Section 112 of the PFMA; and
6. This withdrawal of Section 32 Financial Powers and the Financial Delegates legally comes into effect upon signing of the instrument prior to the date of the publication of this instrument for Southern Highlands Provincial Government in the *National Gazette*.

This withdrawal of financial powers is effective as at 2nd day of February, 2012.

**WITHDRAWAL OF SECTION 32 FINANCIAL POWERS**

I, Steven Gibson, Acting Secretary of Finance, by virtue of the powers conferred by both Section 4 and Section 32(1) of the *Public Finances (Management) Act 1995* and by all other powers enabling me, hereby:

- (a) Revoke the Section 32 Officer Financial Power of the District Administration and the Financial Delegates to approve all Requisitions, DSIP Grants and other Project Development Funds for Lufa District of Eastern Highlands Province;
- (b) The Financial Powers of Section 32 Officer and Financial Delegates to approve all requisition, and of the DSIP Grants and other Project Development Funds for the above district is now revert back to Department of Finance;
- (c) All claim proposals for DSIP Grants and other Project funds for the above district be now forwarded to Finance Department for final vetting and approval for payments;
- (d) Direct that all requisition for expenditure of public monies shall be endorsed by the respective Joint District & Budget Priority Committee before forward to Finance Department for payment;
- (e) An Officer who willfully refuses or neglects to comply with this direction is guilty of an offence under Section 112 of the PFMA; and
- (j) This withdrawal of Section 32 Financial Powers legally comes into effect upon signing of the instrument prior to the date of the publication of this instrument for Lufa District in the *National Gazette*.

This withdrawal of financial powers is effective as at 2nd day of February, 2012.
