the Provincial Land Advisor, as an *ex-officio* member; and

In respect of Section 20(1)(e) — **Wilson Wakpi**

appointed as an alternate Member to represent the private business sector, from nominations received from the Chamber of Commerce; and

(Optional) also in respect of Section 20(1)(e) **Joseph Teng** appointed as an alternate Member to represent the private business sector, from nominations received from the Chamber of Commerce; and

In respect of Section 20(1)(f) — **Sup. Joseph Tondop**—PPC, National Interest Rep *the member appointed by the Minister* in accordance with Section 20(a) of the *Physical Planning Act*; and

In respect of Section 20(1)(g) — **David Laulau**

appointed to represent professions related to physical planning; and

In respect of Section 20(1)(h) — up to three other members who shall include one representative from

- (i) Sporting bodies and groups; or — Mrs. Roslyn Geldi
- (ii) Churches; or — Dr. Scott Dooley

The above mentioned members, in respect of Section 20(1)(e),(f),(g) and (h), are appointed for a period of (up to three years) from the date of this notice.

It is further declared, in accordance with Section 22 and from the above stated membership and after receiving advice from Chief Physical Planner, that the Chairman of the JIWAKA Provincial Physical Planning Board shall be the Provincial Administrator, Mr. Michael Wandil MBE and the Deputy Chairman shall also be appointed for a period of three years effective from the date of gazettal.
