In respect of Section 20(1)(f)—**Supt. Robert Gesa**
the member appointed by the Minister in accordance with Section 20(a) of the *Physical Planning Act*; and

In respect of Section 20(1)(g)—**Clement Nakia**
appointed to represent professions related to physical planning; and

In respect of Section 20(1)(h)—
appointed to represent either

- (i) Sporting bodies, or Groups, Women & Youth Rep—**Maran Nataleo**;
