MINISTERIAL DETERMINATION

PNG LNG PROJECT PIPELINE LICENSE FOUR (PL No.4) SEGMENT FOUR (4) LANDOWNER BENEFICIARY IDENTIFICATION (LOBID) AND BENEFIT SHARING ARRANGEMENT

I, the Minister for Petroleum, Hon. Dr. Fabian Pok, MEC, PhD MP, by virtue of Sections, 169 and 170 of the *Oil and Gas Act 1998* (as amended), and all other powers enabling me hereby make the following Determination on the sharing of 7.28% of the 28% apportioned of the PNG LNG Project, Pipeline License Four (PL No.4), Segment Four (4) on Foe Pipeline Section and Huli Pipeline Section including their percentage split of 30% Foe and 70% Huli impacted beneficiary clans, which are entitled to receive royalty and equity benefits.

Having received and considered results of social mapping and landowner identification studies carried out under S.47 of the *Oil & Gas Act 1998* (as amended), PNG LNG Project DOP Internal Review Reports, signed clan consent forms from the project license area, PNG LNG Project Umbrella Benefits Sharing Agreement, Pipeline License Based Benefits Sharing Agreement, NEC Decision # 193/2015, other related submissions for the purposes of S.169; I, as the Minister responsible for the implementation of the *Oil & Gas Act 1998* (as amended) make the following Determination:

1. Appearing on Part A Schedule 1 is the list of all the beneficiary clans in Pipeline Segment Four (4). These beneficiary clans will receive royalty and equity benefits according to the apportioning percent on their respective pipeline section (Foe Section and Huli Section) as appearing on this Determination.
2. Appearing on Part A Schedule 2 are the percentage split for the three factions (Foe faction, Tikipi faction and Huli faction). The apportioning of royalty and equity benefits as appearing in this determination will be distributed to the beneficiary clans according to these allocated percentages (converted to 100).
3. Appearing on Part B Schedule 1 are the beneficiary clans of Foe faction which are entitled to receive royalty and equity on equal benefit distribution of which 30 % is divided equally to the beneficiary clans as shown on this Determination.

4. Appearing on Part B Schedule 2 are the beneficiary clans of Tikipi faction which are entitled to receive royalty and equity on equal benefit distribution of which 30 % is divided equally to the beneficiary stock clans and will be further apportion to the major clans equally as shown in this Determination.
5. Appearing on Part B Schedule 3 are beneficiary clans of Huli faction which are entitled to receive royalty and equity benefit from the 40 % (converted to 100), which is distributed to the beneficiary clans as shown on this Determination.
