## SUPPLEMENTARY APPROPRIATION (2021) ACT NO. 24 OF 2021

An Act to provide for the appropriation of additional funds for the services of the State, for the year ending 31 December 2021, and for related purposes.

Be it enacted by the President and Parliament as follows-

### **1 Appropriation of amounts under section 34 of the Public Finance and Economic Management Act [CAP 244]**

The additional amount of **VT 4,541,876,529** issued from the Public Fund under section 34 of the Public Finance and Economic Management Act [CAP 244] for the year ending 31 December 2021 is appropriated as set out in the Schedule.

### **2 Commencement**

This Act commences on the day on which it is published in the Gazette.
