OF 1982 VANUATU RED CROSS SOCIETY ACT NO.

To provide for the establishment and operation of Vanuaty Red Cross Society.

Be it enacted by the President and Parliament as follows

Interpretation

- In this Act, unless the context otherwise requires 1. "Committee means the Committee of the Red Cross Society that was in operation before the coming into force of this Act;
 - "Statutes" means the statutes made under section 7
 - "Scheduled Conventions" means the conventions specified in the Schedule;
 - "Society" means the Vanuatu Red Cross Society!

Society

- Establishment of 2.(1) There shall be established a body known as the Vanuatu Red Cross Society which shall be the sole national Red Cross Society in the Republic of Vanuatu
 - (2) The Society shall be a body corporate, having perpetual succession and a common seal, with power to sue and be sued, purchase, acquire, hold, manage and dispose of movable and immovable property, and to enter into any such contracts as it may consider to be necessary or expedient for the purpose of performing its functions or achieving its objects under this Act.

General Objects

- 3.(1) The objects of the Society shall be :-
 - (a) to furnish volunteer aid to the sick and wounded in time of war and to non-belligerents and to prisoners of war and civilian sufferers from the effects of war;
 - (b) in the case of catastrophes or public disasters, to provide the victims thereof with relief
 - (c) in time of peace or war to carry on and assist in work for the improvement of health, the prevention of diseases and the mitigation of suffering in the Republic of Vanuatu and throughout the world;
 - (d) to promote the Junior Red Cross movement among the youth of all races; and
 - (e) to propayate the ideals and the humanitarian principles of the Red Cross with a view to developing a feeling of solidarity and mutual understanding among all men and nations.
 - (2) In carrying out the objects referred to in subsection (1), the Society shall not make any adverse distinctic founded on sex. race, nationality, religion or faith, political opinions or any other similar criteria and shall act in accordance with the spirit and principles of the Scheduled Conventions.

Recognition as a 4. Voluntary Aid Society The Government of Vanuatu shall recognise the Society as a voluntary aid society auxiliary to the public authorities both for the purpose of the Scheduled Conventions and otherwise, and its right in accordance with the Scheduled Conventions to use the heraldic emblem of a red cross on a white ground, formed by reversing the Swiss Federal colours and the designation "Red Cross".

Independence of Society

The independent and voluntary nature of the Societ 5. shall at all times be respected in accordance with the resolution relative to National Red Cross Societies adopted by the General Assembly of the United Nations on the 19th November, 1946.

and Managing Committee

- General Assembly 6.(1) The Governing body of the Society shall be 海 保护學報句 Assembly constituted in accordance with its Statutes made under this Act. There shall also be a managing committee with such powers and duties as may be prescribed by the Statutes.
 - (2) The first members of the General Assembly shall be those persons who, immediately before the coming into force of this Act, are the members of the Committee.

powers to draw up Statutes

- General Assembly's 7.(1) The General Assembly shall as soon as pos≰ible affiter the coming into force of this Act frame and establish a constitution in the form of Statutes for the management of the affairs of the Society and the accomplishment of its objects. Such Statutes shall provide, inter alia :
 - that membership of the Society shall not be (a) witheld from any citizen of the Republic of Vanuatu on the grounds of race, class, sex, religion or faith or political opinions;
 - that all members and associates of the Society (b) shall have representation on the General Assembly.
 - (2) The Statutes may from time to time be altered, added to or replaced by the General Assembly and new statutes may from time to time be made in like
 - (3) The Statutes shall not require to be published Gazette.

Vesting of assets and liabilities, substitution of contracts and saving of appointments

- 8.(1) Immediately on the coming into force of this Act the assets and liabilities of the Committee shall vest in the Society without further authority and without the necessity for further acts except the making of such entries as may be required in any registers kept in accordance with any laws.
 - (2) Entries under subsection (1) shall be made by the appropriate registrar on receipt of a direction in writing made by the Minister.
 - (3) All contracts and agreements subsisting before the coming into force of this Act to which the Committee is a party shall have effect against or in favour of the Society as if it and not the Committee is a party thereto.
 - (4) Officers of the Committee shall hold corresponding appointments in the Society until other provision is made in accordance with the Statutes and Life Associates and Associates of the Committee shall become corresponding Life Members and Subscribing Members of the Society subject to any provision contained in the Statutes.

Commencement

9. This Act shall come into force on such day as the Minister shall appoint by order published in the Gazette.

VANUATU RED CROSS SOCIETY ACT NO. 23 DF 1982

EXPLANATORY NOTE

Conventions (Bill for the Geneva Conventions Act No. of 1982), it can constitute a National Red Cross Society. The purpose of this Bill is to replace the former Committee of the Red Cross Society by the Vanuatu Red Cross Society which will be the sole national Red Cross Society of Vanuatu (section 2). The new body has the same powers as any body corporate. Section 3 sets out the general objects of the Society which reflect the provisions of the four Geneva Conventions. The Bill authorises the Society to use the heraldic emblem in accordance with the Geneva Conventions.

Section 5 is important as it reaffirms the independent and voluntary nature of the Society in accordance with the principles laid down by the United Nations.

The Society will be governed by a General Assembly and managed by a committee established in accordance with the provisions of the statutes (section 6). The Statutes shall be adopted by the General Assembly as soon as possible after the coming into force of the Act and shall contain provisions covered by section 7.

As the new Society will replace the former Committee, all assets and liabilities of this Committee shall vest in the Society. Consequently, contracts and agreements contracted by the Committee shall have effect in favour or against the Society. Besides, officers of the Committee become officers of the Society until replaced in accordance with the Statutes.
