IMPORT OF POTATOES BAN

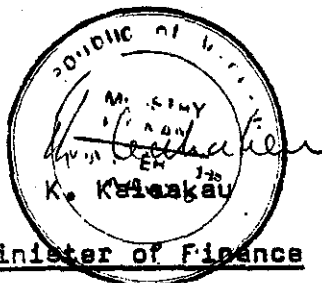
ORDER NO. 129 OF 1981

To prohibit the importation of potatoes.

IN EXERCISE of the power contained in Section 1 of the Joint Control (Fresh Vegetables) Regulation No. 21 of 1977, I hereby make the following Order :-

1. With effect from the date hereof to the 15th day of December, 1981, the importation of potatoes from abroad for consumption on the Island of Efate shall be prohibited.
2. The Import of Vegetables Ban Order No. 105 of 1981 is repealed.
3. This Order shall come into force on the date of signature.



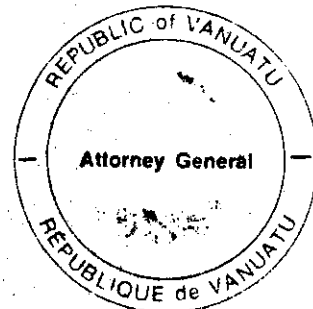

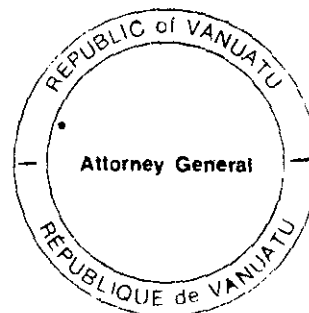
