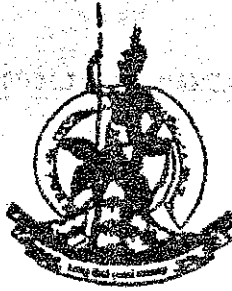

THE (PROVISIONAL) AIRCRAFT CONTROL
ORDER NO. 48 OF 1983

To designate the airport at South West Bay, Malekula Island as public aerodrome.

IN EXERCISE of the power contained in section 8(ii) of the New Hebrides (Provisional) Aircraft Control Joint Regulation No. 12 of 1948, as amended, I hereby declare that as from the date hereof:

- (a) the airport which is situated at South West Bay, Malekula shall be a public aerodrome; and
- (b) any local aircraft whether engaged in the business of public transportation or otherwise may land at and take off from such airport.
